#### ADDITIONAL PROFESSIONAL DEVELOPMENT

The 2024 National Alliance for Public Charter Schools Conference is being held in Boston, MA from June 30-July 3, 2024. The meat of the conference is July 1-2, 2024. This conference would provide an opportunity for Board members to gain insight and information on Public Charter Schools.

## SPECIAL EDUCATION CYCLICAL MONITORING

Lab Charter is in the process of the five-year Pennsylvania Department of Education (PDE) Bureau of Special Education (BSE) Cyclical Monitoring. This is a VERY extensive undertaking and has been ongoing since November 2023. Beginning April 2, 2024, the monitoring team from PDE/BSE will conduct on-site monitoring of ALL special education records for the last five, possibly six years. The LAB team has been working closely with the PDE/BSE team with regular zoom meetings so we don't expect any surprises. I will update in April 2024 after the monitoring is completed. The monitoring requires three additional policies specific to special education.

# SECOND PCCD GRANT FOR LAB CHARTER

LAB would like to submit a safety and security grant through the PDE Crime and Delinquency program. The grant is to hire Play Works at the elementary campus. A copy of the proposal and budget are included for board approval.

# JEFFERSON HOSPITAL EVENT

Dr. Cliatt-Wayman and Dr. Coleman-Hill attended a meeting with the Community Impact Team on March 6, 2024 to discuss the possibility LAB Charter benefitting from the Humana endowment fund with the hope of bringing health services to the Sedgley Campus, which is in an empowerment zone of the city. During the meeting the team offered support with health programs that can easily be integrated into the Sedgley area. These programs will benefit anyone in the North Philadelphia Community where the LAB Charter Elementary School is located. We will continue to meet to discuss a partnership and funding opportunities.

# AFRICAN AMERICAN MULTI-GENERATIONAL TRAUMA & IMPLEMENTING MODELS OF CHANGE

Dr. Coleman-Hill is taking a course on multi-generational trauma. This course focuses on the suffering and traumas associated with the African experience in America inclusive of the periods of capture, transport, enslavement, emancipation leading up to current times. Multigenerational patterns of adaptive behaviors passed along through generations will be explored with an emphasis on assessment and interventions using evidence based, culture specific, and social justice models. The information gained will assist LAB with the development of a post-pandemic trauma informed model for the school community.
